CLARIFICATION TEXT REGARDING PROTECTION OF PERSONAL DATA

II) For what purpose your data will be processed

IV) To whom and for what purposes your personal data will be transferred

IV) The method and legal reason for processing personal data

V) Your legal rights by law

- b) Request information if they are processed,
- c) Learn the purpose of processing and whether it's used according to this purpose,
- ç) Learn about the domestic or foreign third parties to which your data is transferred,
- d) Request to change the data if they have been processed incompletely or incorrectly,
- e) Request to delete, destroy or anonymize the data in accordance with Article 7 of the Law,

- f) Request information on the processes regarding the transfers to the third parties in accordance with the subclauses (d) and (e),
- g) Appeal to any kind of damning result due to the analyzing of your data exclusively with automatic systems,
- ğ) Request compensation for any loss resulting from illegal processing.

Your requests will be realized free of charge as soon as possible in less than 30 days according to the nature of the request. However, if the procedure requires an additional cost, you may be charged according to the price list determined by the Personal Data Protection Board. If you are requesting information on behalf of someone else, you need to include a warrant of attorney and other documents that verify your identification.
